Attorney General Jeff Landry

Jeff Landry became the 45th Louisiana Attorney General or *Procureur general de la Louisiane*, on January 11, 2016.

One of four children raised in a middle-class St. Martinville family, General Landry grew up during Louisiana's oil bust - teaching him personally the effects that a bad economy can have on a family, particularly in a small town. Raised by a school-teacher mother and an architect father, sacrifices were made to ensure their children had the best education possible. General Landry, with hard work and determination, joined the Louisiana National Guard while still in high school.

General Landry worked his way through college as a police officer and a sheriff's deputy. He experienced the necessity of protecting our communities and ensuring the law is faithfully executed by our elected officials, the Attorney General's office, and the courts. As a veteran, General Landry faithfully upheld the oath to protect our civil liberties while keeping our communities safe.

While serving as an aide in the Louisiana State Senate he attained firsthand that many solutions to our problems can be found from listening to the voices of the people and not just to the debates of politicians. In 2010, General Landry was elected to the U. S. House of Representatives where he became known as a ferocious advocate of the Constitution, a leader on the national energy policy, an activist for conservative family values, and a promoter of reductions in wasteful government spending.

General Landry is a veteran of Desert Storm and left the military with the rank of Sergeant. He received the Army Achievement Medal, the Army Commendation Medal, a National Defense Ribbon, an Overseas Training Ribbon and the Louisiana War Cross from his eleven years of service as a member of the Louisiana National Guard.

General Landry earned a Bachelor of Science degree in Environmental and Sustainable Resources with a Minor in Biology from the University of Southwestern Louisiana (now ULL-Lafayette). He and his wife, Sharon, are raising their son, J.T., in Acadiana.






May 2021 Speaker of the Month: Lt. Governor Billy Nungesser

Speaker: U. S. Senator, Bill Cassidy



Senator Cassidy, upon his slightly delayed arrival, faced a nearly packed room filled with mixed emotions. Whether attended by those who came out to hear him speak on the hot button issues; most present were there to hear his explanation, to why he voted to impeach President Donald J. Trump.

He wasted no time and began the Q&A with the inquires being about Medicare, the Retired Teachers of Louisiana Benefits, with a very detailed explanation of how/when the systems were set up; the average life expectancy then, was 62. Now, with the advances in the medical field, many are living past 100 years of age. The retirement system was not designed to sustain the longevity of these retirees. It has even been stated by Senator Cassidy that, “The Social Security System will be bankrupt in 10 years”.

He had talking points, though briefly, on the Asian Hate Crime Bill; he also spoke of Democrats pushing agendas as Defunding the Police, various Covid bills, the border crisis and child care issues evolving from Covid’s “Pay to Stay Home”. The Senator stated that Governor John Bel Edwards, “will not back off on the money”. Governor Edwards is paying extra unemployment benefits though the job market is begging for employees.

Phillip Tarver, La State Rep. 36th District, stated to Senator Cassidy, “The people need to be more accountable”. What he went on the explain is, “those who are collecting Covid Unemployment are given opportunities to return to work.” Many are choosing to remain jobless, because they are paid more on unemployment than from an employer. This is effecting all fields of industry and product availability.


In closing, Senator Cassidy was very adamant that on January 6, 2021 the Capitol was overrun by insurgents, while various Senators remained in constant contact with President Trump. 


(Above) Senator Cassidy in the 'hot seat' during questions about voting to impeach President Donald J. Trump



Senator John Kennedy visits Lake Charles

May 21, 2021



Senator John Kennedy stopped in at the emergency shelter at Trinity Baptist Church in Lake Charles on Friday, May 21, 2021 after receiving word of the flooding that inundated Lake Charles and other areas of Louisiana (most of which is located along the I-10 corridor.)

He relayed to the local media present, “We are a people who go to work every-day...pay our taxes and try to do the right thing by our kids. We try to save some money for retirement; our homes are our biggest asset, and people [here] need the help”.

Governor John Bel Edwards was slow to put forth the state of emergency, again. The flooding was the fourth (4th) weather-related emergency in less than twelve months. There was an even longer delay from the President of the United States for the requested assistance approval. FEMA and other agencies cannot help unless a federal emergency declaration is approved. Senator Kennedy stated, “People need the help, this is what government is for, and I’m going to get an answer, if that answer is NO, then I’m going to keep asking until I get a YES!”

The President finally approved the Emergency Assistance, nearly three weeks into the ongoing rain, which NOAA called the “1,000 year rain” brought on by two tornadic systems merging; causing areas to flood which never have, and a price tag for damage yet to be determined.
